# **How Devonshires' Transition to Template Studio Software Added Significant Value**



Devonshires, a leading City law firm with around 370 staff across offices in London, Leeds, Birmingham, and Colchester, recently transitioned from its former template solution to Novaplex's Template Studio solution. ### Why Devonshires Made the Change

Devonshires had been using its previous template software for years. Although functional, it lacked appeal and innovation. Its outdated interface and persistent issues, such as disappearing macros, left users frustrated. Additionally, Devonshires needed more consistency across templates in different practice areas; a challenge that could not be addressed with the previous solution.

The timing of the shift was also influenced by Devonshires' plans to upgrade its iManage document management system, a move that would require extensive compatibility updates to its old template software. This challenge prompted Devonshires to explore alternative solutions, leading them to consider Novaplex's Template Studio software.

# **Why Devonshires Chose Novaplex**

With face-to-face laptop handovers and training sessions required for every user, careful coordination was essential.

The adaptability of the Novaplex team proved invaluable in meeting these challenges. "They were fantastic," Gavin notes. "They were highly accommodating and flexible, allowing us to complete the transition within the timeline needed to start our laptop rollout."



# Why The Transition Was Worthwhile

The software's core functionality ensures the firm's visual identity remains consistent across documents while still allowing customisation for specific business needs. As Gavin describes, "The templates are now on guiderails to prevent them from straying."

Additionally, integration with Azure Active Directory has streamlined document creation, allowing templates to auto-populate user information, which has been particularly useful for letters created on behalf of others. This automation has reduced errors, saved time, and enhanced accuracy across documents.
